HASCI Case Management Department is ecstatic about the opportunity to assist individuals with Head and Spinal Cord injuries and Traumatic brain injuries. Robert Bell is an individual who is a recipient of a SCDDSN HASCI Waiver. Robert was involved in a motor vehicle accident, where he sustained a Traumatic Brain Injury. Robert is paralyzed on the left side of his body and requires a power wheelchair for his primary mobility. The South Carolina Department of Disabilities and Special Needs approved to purchase a Permobil Power wheelchair so that he could continue to meet his daily needs and continue to be out and engaged in community activities.

### **FOUNDATION**
